Carvey Limited Warranty

Your purchase of a Carvey from Inventables, Inc. ("we," "us," "our") includes the following limited warranty.

Who is Covered by this Limited Warranty?

This warranty is extended only to the original end-user purchaser ("you") of the Carvey.

How Long Does This Limited Warranty Last?

This limited warranty expires on the earlier of (i) 500 hours of use of the Carvey, or (ii) the first anniversary of the date of delivery of the Carvey to you.

What is Covered?

We warrant to you during the period of this limited warranty that the Carvey you purchased from us conforms to our published specifications outlined in Exhibit A, and is free from defects in materials or workmanship. In the event that during the warranty period, your Carvey fails to conform to our published specifications or proves to be defective in materials or workmanship, we will provide you with new replacement parts to correct any such failure or defect. Labor is included for all components, that were not free from defects in materials or workmanship, and not listed in Exhibit B as self serviceable by the customer.

Any replacement product or parts provided to you during the warranty period are warrantied to meet our published specifications and to be free from defects in materials or workmanship for the balance of the original warranty period. Any replaced product or parts become our property.

This warranty extends only to eligible Carvey devices. This warranty does not cover Easel software or any other software sold or provided by us or any third party.

What is not covered by this Warranty

The following items are expressly excluded from warranty coverage:

- Defects in the Carvey related, in any way, to the use of any media that is not included within the approved materials list for Carvey, outlined in Exhibit C, posted by Inventables from time to time.
- The replacement of any part designated below as a "wear part."

- Defects related to any third-party parts, components, or peripheral devices.
- Defects that are only cosmetic in nature.
- Defects related to: failure to perform periodic maintenance as specified in the user documentation; operation for unintended purposes; operation outside of our specifications or user documentation; operation beyond the usage parameters stated in the Carvey user documentation.
- Defects related to improper loading of materials or media in the Carvey.
- Acts of God or other events or conditions outside our control, including fire, flood, lightning, improper electrical currents and the like.
- All other defects, failures or damage not considered failures to comply with published specifications or defects in materials or workmanship.

Wear Parts Not Covered by this Limited Warranty

The following parts are "wear parts" and are not covered by this warranty:

Actions that will void this Warranty

The following actions relating to the Carvey will void this warranty and any defects related to any of the following actions are not covered by this warranty:

- Use of any non-Easel software or any software provided by a third party to directly control the machine.
- Alteration to any hardware or firmware included with the Carvey.
- Overriding or attempting to override the interlock or guards and removing or attempting to remove any guards or other safety features.
- Misuse, abuse, accident, neglect, or improper storage when not in use for extended periods.
- Use for any unlawful purpose.
- The performance of service on the Carvey by anyone other than you, us or a service representative designated by us.
- Using any material not approved for use in Carvey in Exhibit C

^{*}Safe limits for Aluminum are as follows: 5"/min feed rate, 2.5"/min plunge rate, 0.003"/pass with minimum 0.0625" milling bit.
